In accordance with the provisions of Chapter 90, Section 18, of the General Laws (Ter. Ed.) as amended, the following Special Speed Regulation is

hereby Adopted

by the Board of Selectmen

of the Town of Sherborn

That the following speed limits are established at which motor vehicles may be operated in the areas described:

SNOW STREET-NORTHBOUND

Beginning at Route 27 Thence northerly on Snow Street

0.23 miles at 25 miles per hour

0.14 miles at 20 miles per hour ending at Forest Street; the total distance being 0.37 miles.

SNOW STREET-SOUTHBOUND

Beginning at Forest Street Thence southerly on Snow Street

0.14 miles at 20 miles per hour

0.23 miles at 25 miles per hour ending at Route 27; the total distance being 0.37 miles.

PROSPECT STREET-EASTBOUND

Beginning at Framingham Town Line Thence easterly on Prospect Street

· 1.41 miles at 25 miles per hour ending at Coolidge Street; the total distance being 1.41 miles.

PROSPECT STREET-WESTBOUND

Beginning at a point 250 feet west of Coolidge Street Thence westerly on Prospect Street.

1.36 miles at 25 miles per hour ending at the Framingham Town Line; the total distance being 1.36 miles.

HUNTING LANE-EASTBOUND

Beginning at Perry Street and Brush Hill Road Thence easterly on Hunting Lane

0.63 miles at 30 miles per hour

0.21 miles at 15 miles per hour

0.56 miles at 30 miles per hour
0.16 miles at 20 miles per hour ending at Route 27;
the total distance being 1.56 miles.

HUNTING LANE-WESTBOUND

Beginning at Route 27 Thence westerly on Hunting Lane

0.16 miles at 20 miles per hour

0.56 miles at 30 miles per hour

0.21 miles at 15 miles per hour

0.63 miles at 30 miles per hour ending at Perry Street and Brush Hill Road; the total distance being 1.56 miles.

BRUSH HILL ROAD-EASTBOUND

Beginning at Western Avenue Thence easterly on Brush Hill Road

0.29 miles at 25 miles per hour

0.62 miles at 20 miles per hour ending at Perry Street & Hunting Lane; the total distance being 0.91 miles.

BRUSH HILL ROAD-WESTBOUND

Beginning at Perry Street and Hunting Lane Thence westerly on Brush Hill Road

0.62 miles at 20 miles per hour

0.29 miles at 25 miles per hour ending at Western Avenue; the total distance being 0.91 miles.

MILL STREET-NORTHBOUND

Beginning at Holliston Town Line
Thence northerly on Mill Street

1.32 miles at 25 miles per hour ending at Woodland Street;
the total distance being 1.32 miles.

MILL STREET-SOUTHBOUND

Beginning at Woodland Street Thence southerly on Mill Street

1.32 miles at 25 miles per hour ending at Holliston Town Line; the total distance being 1.32 miles.

Operation of a motor vehicle at a rate of speed in excess of these limits shall be prima facie evidence that such speed is greater than is reasonable and proper.

The provisions of this regulation shall not, however, abrogate in any sense Chapter 90, Section 14, of the General Laws (Ter. Ed.)
