In accordance with the provisions of Section 18 of Chapter 90 of the General Laws (Ter. Ed.) the following Special Speed Regulation is hereby promulgated:

Special Speed Regulation numbers 207 and 350 dated January 10, 1961 and July 5, 1966, respectively are hereby amended by striking out the Regulations in their entireties and inserting in place thereof:

The following designated speed limits are established at which motor vehicles may be operated in the areas described:

## ASSTBUUND

Beginning in W. Stockbridge at the New York - Massachusetts State line, Thence casterly.

0.23 miles at 40 miles per hour

Highway, West of town.

And beginning again in W. Stockbridge at the beginning of State Highway, east of town
Thence easterly

0.12 miles at 30 miles per hour

0.36 " " 45 " " "

0.40 " " 50 " " to the Stockbridge Line.

Thence easterly in Stockbridge

0.57 miles at 50 miles per hour

0.58 " " 40 " " "

0.63 " " 50 " " "

0.30 " " 40 " " "

And beginning again in Stockbridge, at the beginning of State Highway, est of town, ence easterly

0.39 miles at 35 miles per hour

Thence easterly in Lee,

0.80 miles at 35 miles per hour

1.79 " " 50 " " "

U.S. Route 20; the total distance being 10.52 miles.

Beginning in Lee, at Station 169+80

Thence westerly

0.15 miles at 30 miles per hour

0.80 " " 35 " " to the Stockbridge Line.

Mence westerly in Stockbridge

0.05 miles at 35 miles per hour

0.55 " " 45 " " "

0.39 " " 35 " " ending at the end of State

And beginning again in Stockbridge at the beginning of State Highway, west of town

Thence westerly

0.69 miles at 50 miles per hour

0.30 " " 40 " " "

Thence Westerly in W. Stockbridge

0.40 miles at 50 miles per hour

Highway, east of town.

And beginning again in W. Stockbridge, at the beginning of State Highway, west of town Thence westerly

0.19 miles at 25 miles per hour

0.43 " " 35 " " "

1.75 " " 45 " " "

0.23 " " 40 " " ending at the end of State Highway, at the Massachusetts - New York State Line; the total distance being 10.47 miles.

Operation of a motor vehicle at a rate of speed in excess of these limits shall be prima facie evidence that such speed is greater than is reasonable and proper.

The provisions of this regulation shall not, however, abrogate in any sense, Section 14 of Chapter 90.

The Department of Public Works and the Registrar of Motor Vehicles. -ting jointly do hereby certify in writing, that this regulation is \_\_nsistent with the public interest.

Standard signs must be erected at the beginning of each zone.
