In accordance with the provisions of Chapter 90, Section 18, of the General Laws (Ter. Ed.) as amended, the following Special Speed Regulation is

hereby Adopted

by the Board of Selectmen

of the Town of Reading

Special Speed Regulations Numbered 133 and 242 dated April 9, 1957 and November 13, 1962 respectively are hereby amend d by striking out the regulations in their entirety, and inserting in place thereof the following revisions and addenda.

That the following speed limits are established at which motor vehicles may be operated in the areas described.

High Street - NORTHBOUND

Beginning 200 feet north of Washington Street,

Thence northerly on High Street

0.89 miles at 30 miles per hour ending at Route 129; the total distance being 0.89 miles.

High Street - SOUTHBOUND

Beginning at Route 129,

Thence southerly on High Street

0.89 miles at 30 miles per hour ending at Washington
Street; the total distance being 0.89 miles.

West Street - NORTHBOUND

Beginning at the end of State Highway,

Thence northerly on West Street

0.61 miles at 30 miles per hour

O.37 " " 35 " " ending at the Wilmington Town line; the total distance being 1.69 miles.

West Street - SOUTHBOUND

Beginning at Wilmington Town line,

Thence southerly on West Street

0.37 miles at 35 miles per hour

of State Highway; the total distance being 1.69 miles.

Haverhill Street - NORTHBOUND

Beginning at the end of State Highway.

Thence northerly on Haverhill Street

Summer Avenue - NORTHBOUND

the total distance being 1.97 miles.

Summer Avenue - SOUTHBOUND

Beginning 300 feet south of West Street,

Thence southerly on Summer Avenue

0.25 miles at 25 miles per hour 1326

ending at Brook Street;

1.66 " " 30 " the total distance being 1.91 miles.

Route 129 - EASTBOUND

Beginning at the Wilmington Town line,

Thence easterly on Route 129

0.52 " " 35 " " ending at the beginning of State Highway; the total distance being 2.61 miles.

Route 129 - WESTBOUND

Beginning at the end of State Highway,

Thence westerly on Route 129

0.51 " " 40 " " ending at the Wilmington

Town line; the total distance being 2.61 miles.

Operation of a motor vehicle at a rate of speed in excess of these limits shall be prima facie evidence that such speed is greater than is reasonable and proper.

The provisions of this regulation shall not, however, abrogate in any sense Chapter 90, Section 14, of the General Laws (Ter. Ed.).
