Special Speed Regulation numbers 151, dated March 4, 1958 and 151-A, dated January 19, 1966 are hereby amended by striking out the Regulations in their entireties and inserting in place thereof the following revisions:

The following designated speed limits are established at which motor vehicles may be operated in the areas described.

NORTHBOUND

Beginning in Whitman, at a point 116 feet north of the beginning of State Highway
Thence northerly

0.36 miles at 35 miles per hour

0.33 " " 40 " " " to the end of State Highway, at the Brockton City Line.

And beginning again in Brockton, at a point 251 feet north of the beginning of State Highway,
Thence northerly

0.36 miles 35 miles per hour

Line.

Thence northerly in Stoughton,

1.67 miles at 40 miles per hour 0.11 " 20 " "

0.48 " " 35 " " " ending at the end of State Highway; the total distance being 5.30 miles.

SOUTHBOUND

Beginning in Stoughton at the beginning of State Highway, Thence southerly

0.48 miles at 35 miles per hour 0.16 " 25 " " "

1.62 " " 40 " " to the Brockton

City Line.

Thence southerly in Brockton

0.22 miles at 40 miles per hour

0.16 " " 25 " " "

0.62 " 45 " " 0.31 " 40 " "

0.10 " " 25 " " ending at the end

of State Highway.

And beginning again in Whitman at the beginning of State Highway,
Thence southerly

0.33 miles at 40 miles per hour

0.99 " " 45 " " "

0.38 " " 35 " " ending at the end of State Highway; the total distance being 5.37 miles.

Operation of a motor vehicle at a rate of speed in excess of these limits shall be prima facie evidence that such speed is greater than is reasonable and proper.

By striking out the clauses reading:

Beginning in Stoughton at the beginning of State Highway, thence southerly

0.48 miles at 35 miles per hour

and

the total distance being 5.37 miles

And inserting in place thereof:

Beginning in Stoughton, 398 feet south of the beginning of State Highway, thence southerly

0.40 miles at 35 miles per hour

and

the total distance being 5.29 miles
